THE ORGANIZATION PROVIDES INFORMATION AND TRENDS ANALYSIS; LEADS COLLABORATIONS IN THE AREAS OF CHILDREN AND YOUTH, POVERTY AND HOMELESSNESS, AND SUBSTANCE ABUSE; MOBILIZES COMMUNITY RESPONSE TO EMERGING COMMUNITY ISSUES; ADVOCATES FOR POLICY CHANGES; AND LEVERAGES RESOURCES TO INCREASE THE COMMUNITY'S CAPACITY TO RESPOND TO HUMAN SERVICE NEEDS.
