

Annual Indicator Trends

Each annual profile includes data on multiple indicators for five counties in the Kansas City metro area and the five counties combined. The counties are Johnson and Wyandotte in Kansas, and Cass, Clay, and Jackson in Missouri.

The "5 county indicator trends" worksheet represents the total of the five county indicator data. Exceptions are noted by MSA. When data was not available for every county, data for the MSA was used rather than the five county total.

The U.S. Census Bureau published limited Platte County estimates in 2016 due to unspecified sampling error in the Platte County, MO data. Prior to 2016, the "5 county indicator trends" worksheet included Platte County.
