

Poverty in Johnson County Cities


More than 32,000 Johnson County residents, or 6% of the population, live below the federal poverty level, according to 5-year estimates from the U.S. Census Bureau. Thousands more earn just enough to avoid the technical definition of poverty, which was \$12,430 and \$37,290 for a family of three in 2023.

UCS uses 5-year estimates to track poverty in local cities, because the Census Bureau provides only 5-year estimates (rather than 1-year estimates) for jurisdictions with fewer than 65,000 people.

While poverty can be found throughout Johnson County, mapping analysis conducted by Johnson County Department of Health and Environment (JCDHE) indicates that poverty is greater in certain geographic locations.


Census tracts with relatively higher poverty rates are in the Northeast suburbs, the county seat of Olathe, urban communities along the I-35 corridor, and the rural areas of Edgerton and De Soto. Poverty at the city level varies by age group. In most of the large cities in Johnson County, the rate of poverty for young adults (also known as transitional-age youth age 18-24) is higher than that of any other age group.

Individuals and families in poverty do not have enough income to meet their basic needs. As a result, they have limited resources with which to choose safe and affordable housing, healthy food, reliable transportation, and health care services. Poverty is one of the most prevalent social determinants of health and has implications for where, how, and how long a person lives. Cities should consider innovative programs as well how policy and system reform opportunities when considering how to address the needs of residents in poverty.
